

CARLI Statewide Serials Collection Task Force (SSCTF)
Final Report
May 15, 2007

Charge of the Task Force: The Statewide Serials Collection Task Force shall investigate various collaborative options related to print and electronic serials collections across the state. Among other ideas, these options may include mechanisms for last subscription retention, last copy retention and electronic archiving. Task Force recommendations for new CARLI products or services shall be made to the CARLI Product and Services Vetting Committee.

The Task Force was asked to submit a final report by June 1, 2007.

I. Introduction

Among CARLI libraries, as with most academic libraries of all sizes, serials costs dominate materials budgets. Data from the National Center for Education Statistics (<http://nces.ed.gov/surveys/libraries/compare/index.asp?LibraryType=Academic>) show Illinois academic libraries spent \$67 million in FY04 on continuing resources (print and electronic). Smaller libraries may spend proportionately less of their budgets on serials, while science and medical collections may spend proportionately more. While cooperative purchasing of electronic resources has become commonplace, major issues still exist with paper serial subscriptions as well as individual electronic titles that may or may not be part of publishers' aggregated packages.

Before the transformative changes necessitated by electronic serials, libraries and consortia addressed the need to cooperate on serials coverage among libraries through union lists that selectors could consult easily. Collection development agreements tended to parallel monographic subject-oriented agreements. Discovery and delivery developments, including easy linking to online article citations and pay as you go access models, are some factors that have led to changes in the need for and uses of information about serials holdings. The major change has been the wide availability of full-text online for users as a replacement for indexes, paper and microform backfiles, and union lists. Aggregator packages further complicate matters as it is no longer a matter of ownership, but rather of leasing access to titles. Another issue is that the full-text holdings available are not consistent, and current issue embargoes are common. A major resulting challenge has been to maintain both current and retrospective coverage of needed titles online, often in duplication of an institution's paper and microform holdings. No tool like a union list exists for online holdings aside from products such as SFX or Serial Solutions that

function as link-resolving union lists. This lack of a central source of holdings information is a key barrier to informed decisions about retention of serial backfiles in a cooperative manner following defined consortial collection development guidelines. Because of resources constraints, many libraries have not maintained current records of their own paper serials holdings within I-Share or OCLC, making finding information on holdings even more difficult.

Researchers from the University of Illinois at Urbana-Champaign, Tina Chrzastowski, Chew Chat Naun, Karen Schmidt and Michael Norman, did an extensive study of science serials coverage with support from the former Illinois Cooperative Collection Management Program (ICCM). Their article "Feast and Famine" (*College and Research Libraries* forthcoming November 2007) examines the process of gathering information and describes many of the difficulties encountered as part of the excellent analysis it presents. Their efforts formed the basis for the SSCTF's foundation and beginning discussions.

On the simplest level, the Task Force wanted to address the everyday questions faced by librarians, such as what to do with bound volumes of journals with duplicated holdings in JSTOR, what to do when faced with the need to cancel longstanding serials subscriptions, and how to assess the uniqueness of serials holdings. On another level, the Task Force wanted to address long-term issues, such as archiving and budget planning as serials increasingly become electronic continuing resources only, with no paper involved. Preserving access to information produced in serial format is a crucial role research libraries play, but is a responsibility felt by many types of libraries to lesser extents. And finally, the Task Force welcomed the opportunity to examine those titles that were commonly held across Illinois libraries, as identified by a high degree of either title overlap or publisher-title overlap, in order to recommend that they be candidates for a consortia contract for online access. Libraries in Illinois need to find some relief from the impossible demands that serials place on already overburdened budgets. Collaborative action on shared package/title purchases may well provide for that relief.

Some questions the Task Force considered were:

- What are the issues inherent in a statewide serials collection?
- Should Illinois or CARLI libraries be making an effort to preserve subscriptions to serial titles in paper? Should related paper or microform backfiles be preserved, and if so, where and how?
- If subscriptions should be maintained, how should coverage be recorded? Is there a core journal collection the state should have?
- What are good criteria for recommending joint purchases? What is the process for doing so?
- What role should cooperative collection development efforts have in relation to the shift to electronic subscriptions and backfiles?
- Are electronic subscriptions and backfiles sufficient for preservation? What preservation efforts on the national and international level are Illinois libraries already participating in? What role might CARLI play?

- How can libraries analyze and document existing serials coverage? How can information about both paper and electronic subscriptions best be integrated?
- Should we look first at which titles are held by only a few places? Ones which are not available electronically? Or should we consider which titles are most widely held first?
- What role might e-resource management systems play? What do libraries know about them?
- To what extent are libraries considering preservation issues when switching from print to electronic subscriptions?

The Task Force determined its first steps as investigating other states' and consortia's efforts, investigating what information could be gathered on serials holdings and coverage statewide with existing tools, looking at what other tools might be available, and considering what education might be needed for CARLI members to consider the serials issues effectively. This report makes some preliminary recommendations and addresses the questions above as well as many others that occurred throughout the eight months of discussions.

II. Survey of efforts in other states and consortia

Members of the Task Force contacted consortia in other states regarding their initiatives with a group approach to statewide serial collections. Consortia contacted were.

- GALILEO (Georgia)
- VIVA (Virginia)
- LALINC and LOUIS (Louisiana)
- OhioLink
- MOBIUS (Missouri)

Each consortium has explored collaborative serial efforts, with most of the efforts focused on purchases of full-text online journals and/or databases. Efforts to identify and maintain access to serial last copies were attempted in the past by several consortia, but there was limited follow-up.

The consortia shared an awareness of the need to address shared serials collections. Efforts with LOCKSS and Portico are underway in most places. Most of the efforts addressed group purchase of JSTOR, Cambridge, Blackwell/Wiley and nursing titles, using an opt-in model where member libraries paid some portion of the cost for access rather than the consortium footing the whole bill. Also, the consortia typically subscribed to entire e-journal packages from publishers rather than subscribing on a title-by-title basis. All efforts seemed to be similar to those done by various CARLI groups; there did not seem to be substantial differences.

III. Investigations

A. Task Force members also investigated possible tools for the assessment and comparison of serials holdings. WorldCat Collection Analysis, to which participating CARLI libraries had access through December 2006, was used to assess title overlap, and to yield a report on titles widely held throughout the state. The idea was to expand the subject coverage analysis beyond the original science serials analysis done with the original ICCMP grant, using the Ulrich's serials analysis product. (The Task Force investigated the Ulrich's product also, and found it not developed enough to provide desired results reliably and too costly for this investigation.)

The statewide WorldCat Collection Analysis product included data from 91 Illinois libraries, including all I-Share libraries plus Northwestern University, University of Chicago, and the Chicago Public Library. Task Force member Chad Buckley used the WorldCat product to compile a list of print serial titles held by 30 or more of the 91 libraries. He then conducted a "Uniqueness" search and focused on the data for the University of Illinois at Urbana-Champaign, assuming that it would hold essentially all of the most commonly held titles. He then examined the data for titles held by the largest number of libraries ranging from one title held by 82 libraries down to those held by 30 libraries. This was later shortened to titles held by 40 or more libraries (Appendix I).

The WorldCat data included serial titles that might not be active subscriptions, so Chad attempted to quantify how much this would affect the data. He analyzed two sample titles, *Nature* and *Physics Teacher*. According to the WorldCat data, *Nature* was held by 64 libraries and *Physics Teacher* by 40 libraries. When he cross-checked this against individual catalogs, he found that 50 out of 64 libraries had current subscriptions to *Nature*, and 26 out of 40 libraries has current subscriptions to *Physics Teacher*. Thus the figures from the WorldCat data were inflated and did include libraries that no longer held active subscriptions. While numbers for many titles may have declined due to cancellations, these are still probably the most widely held titles in the state based on the sources consulted. The order of titles on the list might change slightly due to cancellations, but data that precise were not necessary for this analysis.

B. A larger issue is that the data only reflected print serials and not electronic titles. A follow-up analysis showed that including electronic serials could affect the number of libraries holding a title, but not to a great extent. The number of libraries for the top 25 most widely held print titles were completely unaffected by including electronic titles except for two titles, and figures for the number of libraries for those two titles only changed upward or downward by one. Task Force Chair Ann Riley, with the assistance of CARLI's Cathy Salika, looked at overlap of electronic titles among CARLI libraries who have installed SFX. There was a very high degree of overlap among libraries. Few libraries had SFX completely operational, so the information was deemed not useful for this study.

Task Force member Jan Sung compiled coverage of the most widely held titles by aggregator databases that were accessible statewide (Appendix II). Once the list of titles was compiled, Chad scanned through to try to account for obvious title changes and remove superseded titles. He included publisher information from WorldCat and used Ulrich's and publishers' lists to verify current publisher information. Chad then analyzed

the data to find out which publishers were most represented by the widely held titles. He then compared the number of titles for the larger publishers against their entire list of titles published to determine what percentage of that publisher's list was included in the titles widely held in the 91 libraries. By examining these findings (Appendix III), CARLI could focus its activity on providing publisher packages that would be of the greatest benefit to its member libraries. CARLI could also consider providing access to the most widely held periodical titles in Illinois, if the idea were to subsidize the access.

C. Another investigation involved the statewide paper and microform holdings for JSTOR Arts and Sciences Collection I titles (Appendix IV). Task Force member Todd Spires began by asking if it made sense for multiple libraries in the state to maintain paper or microform holdings for serials, if most of the libraries hold the titles in an electronic collection. As the Task Force was charged to discuss, might libraries benefit from an organized program to collect a "last copy" of these titles so that weeding could take place. A JSTOR collection was chosen because of its perceived stability and wide ownership. The idea was not to determine complete volume by volume holdings for each title for each library, but to count the number of libraries holding each title. The assumption was that this would provide another study of general holdings across the state.

Of the 119 titles in the Arts and Sciences Collection I, 100 (84%) were held by more than ten libraries. Each title was checked against I-Share to determine holdings, and both paper and microform holdings were counted. The process was very simple, but complicated by the fact that some libraries have their electronic holdings listed on paper and microform records. In those instances, the libraries were omitted from the count. Counts appear on the spreadsheet in Appendix IV. Although they did not check exact holdings, researchers assume in this case there are multiple libraries with complete holdings for each title. If a title reflected less than ten holding libraries, researchers looked more closely at the run of holdings. Libraries with complete holdings for each title were identified. If fewer than three libraries showed complete runs, they are mentioned on the spreadsheet. Only four titles show the lack of a complete run of holdings. This does not mean that there are no libraries in the state with such a run, but rather indicates a lack of information due to the complexity and variety of I-Share holdings information as subject to local constraints and policies.

The identification of individual libraries as last copy owners within CARLI is a beneficial service, as it could ensure that a last copy would be maintained within the state and allow other libraries to weed their holdings. This could be done one electronic collection at a time or done as a one large project. Lack of reliable information on serials holdings statewide, however, may be a significant obstacle for this project.

IV. Serials holdings data for a statewide collection approach

Throughout the investigations described above, lack of uniform and current information made data-gathering difficult and frustrating at times. The authors of the original ICCMP-funded study reported the same. Major problems are inherent in shared serial bibliographic and holdings records, and this lack of clear data seems to have acted as a deterrent to would-be researchers on this topic. Problems with serial records are well

known, and include the need to record issues like format, ownership, license agreements, cooperative agreements, when a library started and ended subscriptions, title, publisher and platform changes, and years and volumes available.

Libraries in Illinois have two main options for serials record holdings maintenance. Local holdings may be maintained in the OPAC with volume holding or summary holdings statements. Some libraries supplement this with printed serials lists. Some of these libraries also contributed serial holdings to OCLC under the SILO union list, which was a critical tool to share serial information throughout the state. Unfortunately, maintenance of the list required duplicate entries in the local system and then in OCLC. Batch load processes are good options if data can be extracted from the local system, or loaded, in the reverse, from OCLC if maintenance is done there. OCLC offers batchloads along with other options to add electronically available serials holdings. (See www.oclc.org/productworks/eserialspilot.htm). To develop a statewide approach to the serials collections of libraries, those libraries must have accurate information to share. The Task Force recognizes that resource issues are involved and that labor costs are not insignificant, but Task Force members have also been surprised at how little information has been consolidated to make more efficient the purchase and use of the enormously expensive asset that serials have become.

V. Preservation

A statewide serials collection requires that access be maintained whether in print or electronic format. As more publishers drop print and as libraries flip their subscriptions from print to electronic only, questions intensify on the maintenance of access to non-current issues. Libraries for many years have been carefully preserving print, and moving to microforms became the space-saving solution for some libraries in the 1960s. User satisfaction with microforms, often lukewarm, is now waning further in the face of online access. Seeing a market opportunity, some publishers are eager to scan backfiles of paper journals from libraries to sell to other libraries in electronic format. The question of print archives of journals may be addressed by identifying last copies available and designating a last copy depository. Most Task Force members as well as other librarians apparently assign this role to the University of Illinois at Urbana-Champaign by virtue of its combined research and public missions. If possible, this role should be clarified and formally accepted by the University Libraries, if it has not already been articulated. Consensus on the Task Force is that preservation needs to be considered on a title-by-title, or collection-by-collection basis in the case of some electronic collections, and that a paper or secure electronic copy of most titles should either be maintained within the state or be accessible for a state institution to make available within the consortium.

Last copy guidelines were discussed by the Task Force, including the application of the existing monographic last copy guidelines. Based upon the task force's discussion and the experiences related by the other consortia polled, the Task Force decided that retention of last current subscriptions within the state was not feasible to enforce or support consortia-wide and that local conditions must prevail. Retention of backruns is more amenable to consortia action. The Task Force discussed two potential pilots for preserving serial backfiles. One is to build upon a program being tested by the University of Illinois libraries and expanded to several other state university libraries to mutually

agree on retaining identified serial backruns. The other potential pilot is based on retaining a print run of JSTOR titles. A Serials Working Group could oversee these pilots, including deliverables and evaluation.

Efforts should be made to identify titles “at risk” for last copy preservation with special attention to titles with local interest for libraries in their user communities. Coordination should be done with past projects, perhaps with consideration toward digitization efforts.

VI. Education on the issues

A statewide serials collection approach affects many groups within the library, as all are in need of resources to support their work in the midst of change. Staff in all parts of library operations will need to be considered when developing educational programs. Special attention should be paid to smaller libraries for whom some issues may be less acute but who may have unique titles or collections with special needs. Education for library administrators will need to include information on the context for developing a statewide approach to serials collections, models for moving to electronic-only backfiles if desired, sources of data analysis, preserving print resources, and the need for accurate serials holdings information. Staff at CARLI and OCLC may need to provide additional training on serials holdings records in particular for library staff members working in technical services.

Methods for achieving these educational outcomes would include the usual meetings plus FAQ sheets, workshops and organization of project information on a web site. Members of the Task Force and Serials Working Group may also consider presenting this work at related conferences, such as the North American Serials Interest Group (NASIG) meetings.

VII. Recommendations

The Task Force recommendations are in five areas:

A) Ongoing

1. Form a Serials Working Group, reporting to the CARLI Board, under the auspices of Collections Services, that is equivalent to the working groups on Preservation, E-Resources, and Collections, with the same general guidelines on membership and reporting. Inclusion of the Serials Working Group chair in regular meetings with the other Working Group chairs will ensure information sharing on projects of common interest. The suggested charge for the Serials Working Group is:

The CARLI Serials Working Group provides advice to the CARLI Board on issues surrounding the serials collections across the state considered collectively. It develops and facilitates ongoing projects addressing serials subscriptions, overlap, retention, and other related collections issues.

2. Direct CARLI Collections Enhancement Awards eligibility to include data input, upgrading of holdings records, and records purchases to further

statewide serial data availability, as this significantly enhances use of expensive assets

B) Serials collection analysis

1. Establish that the best source of canonical statewide serials holdings data is OCLC
2. Assist and educate members on options to input and then maintain local holdings data (Connexion and batch load):

3. Remind members of the importance of best practices in serials and other continuing resource cataloging and holdings data, which underpin diverse initiatives including, but not limited to: ILL delivery, including the RAPID initiative
<https://rapid2.library.colostate.edu/PublicContent/AboutRapid.aspx>); link resolver implementations; vendor article purchase options; and collection comparisons and analysis
4. Defer selection of a preferred product for serials collection analysis until commercial tools are better developed and better CARLI serials data is available through member efforts

C) Serials retention

1. Develop last copy serials retention guidelines for CARLI members
 - i. Last active subscription (paper, electronic, microform): No recommendation. Local needs and experiences will prevail. Cooperative approaches within subject areas could be considered.
 - ii. Last backfile
 1. Paper: One print copy of a serial title should be retained in the state. Pilot projects should be undertaken to develop final guidelines.
 2. Electronic: Consider digital archive options
 3. Microform: Follow print model, though this is the least preferable format for last copies
2. Maintain and promote CARLI membership in Portico (already recommended and initiated in April 07)

D) Serials collection purchases

1. Approach publishers of widely-held titles as identified by the SSCTF WorldCat title overlap studies to investigate consortial licensing of titles and explore new negotiation paradigms, with the consortium taking a proactive approach to customized statewide licenses
2. Encourage selective purchases of e-journal backfiles to improve statewide access, ease local space constraints, and free local dollars for other titles

E) Educational activities

1. Work with other relevant CARLI and I-Share groups to provide education on taking a statewide approach to the serials resources owned in the state, and on the quality of serials holdings data required to support consortia activity and decision-making

2. Plan and present a forum within the next year to provide models for transitions to e-only serials and attendant issues; use pilot projects as focus of presentations
