## Accomplishments

- Sponsored the Streaming Video Symposium with the Electronic Resources Working Group in July. The event had 92 registered attendees with presentations from 10 individuals from 6 different CARLI institutions that included an overview of streaming video, case studies on how different institutions implement streaming video, as well as cataloging streaming video, and free resources that are available.
- Developed a maintenance schedule for the CARLI Scholarly Communications website and is responsible for continued monitoring and updating of the site
- Monitored progress of the CARLI Last Copy Project
- Facilitated the FY2011 Book Digitization Initiative by soliciting and reviewing proposals. The submission process was revised to include a cost share for institutional publications of lesser interest to the entire state.
- Formed a sub-group to plan a Collections Working Group Forum on “Open Access Collection Development” for Fall 2011
- Developed survey to collect information about special collections in the state of Illinois
- Created presentations for podcasts on “Using ILL reports for Collection Analysis,” “Counter Reports and how to employ them,” and “UStat” for a series on using tools for collection development and assessment
- Continued *Digitized Book of the Month* on the CARLI blog to feature the CARLI Book Digitization Initiative and the digitized materials
- Promoted the Collections Resources Clearinghouse to the consortium as a repository for collection development guidelines and best practices
- Formed task force to study and make a recommendation to the CARLI Board on the number of duplicate copies in I-Share

## Future Objectives

- Complete recommendation to the CARLI Board on the number of copies in I-Share
- Complete planning for the forum on Open Access Collection Development for Fall 2011
- Continue to develop podcasts on assessment tools for collection development
- Continue the development of the Collections Resources Clearinghouse
- Facilitate and promote the Book Digitization Initiative program
- Provide leadership in exploring new directions for cooperative collection development and patron driven acquisition within the consortium
