## **Saskia Art Images Collection**

### **SECTION 3.0 PROHIBITED USES AND LIMITATIONS**

**Revised April 17, 2006**

**The following section is one section of the agreement between the Board of Trustees of the University of Illinois and Saskia Ltd. Cultural Documentation. “Licensee” refers to the Board of Trustees of Illinois, acting on behalf of the Consortium of Academic and Research Libraries in Illinois. “Authorized Sites” refers to the Consortium of Academic and Research Libraries in Illinois whose members are listed at <http://carli.illinois.edu/members.php>**

#### **3.0 PROHIBITED USES AND LIMITATIONS**

- 3.1** Saskia hereby reserves all rights not expressly granted herein.
- 3.2** The Licensed Software may not be used for preparation of any publication, scholarly or otherwise; or for any purpose other than teaching or research. Publication of an image from the Licensed Software requires a separate license from Saskia.
- 3.3** Licensee agrees not to resell, lease, transfer, sub-license or otherwise distribute a copy of the Licensed Software, or any image taken from the Licensed Software, in whole or in part. Licensee may distribute copies of the Licensed Software (digital images) to Authorized Sites. Additional copies of Licensed Software may not be distributed by Authorized Sites.
- 3.4** Licensee also agrees not to modify, corrupt or alter any digital image graphic content or “digital watermark” or the like in the Licensed Software provided by Saskia under this Agreement.
- 3.5** Licensee agrees not to remove, alter, cover or distort Saskia’s copyright notice, trademark, or other proprietary rights notice placed by Saskia in the Licensed Software itself, or in the associated packaging, media or documentation.
- 3.6** Licensee agrees to notify Authorized Users of the Licensed Software, in writing or by sign-on screen display, of their obligations under this Agreement and solicit their cooperation and compliance with such obligations.
- 3.7** Digital Images shall be identified by Saskia Catalog Numbers. Licensee agrees that Saskia’s numbering system shall remain in use at the site to aid in

identification of works. Additional identification may be used as long as a cross-reference to Saskia's Catalog Numbers is maintained.

- 3.8** Licensee shall at all times retain a complete list of Licensed Software, along with documentation demonstrating payment of license fees.
- 3.9** Licensee agrees that Saskia shall have absolute discretion in identifying works by Saskia Catalog Number.
- 3.10** Licensee agrees that in the case of duplicate Saskia Catalog Numbers, Saskia shall provide correct identification for purposes of this Agreement.
- 3.11** Saskia shall provide electronic files with each order identifying Licensed Software by catalog number. In addition, a complete list of Licensed Software shall be available to the licensee via mail or the Saskia web site.
- 3.12** Thumbnail images (smaller versions of larger image files) may be viewable by users without limited security access. Only Authorized Users will be permitted to click on the thumbnail image and enlarge the image to its full size.
