Research Subsidy – CARLI terminology

Goals

- Potential to positively impact libraries & the library profession
- Potential to provide a useful addition to the existing literature
- Results should be of interest or of use by other CARLI libraries

Research

- All aspects of librarianship
- Theoretical or practical
- Refer back to the goals of the program

Funding

- Total Available: \$25,000
- Maximum for any proposal: \$4,999
 - multiple institutions
 - multi-year projects
- Travel to present research findings: \$1,000
- Indirect costs, such as college/university administrative costs will not be covered
- Personal Stipends (NO)

MS Word version on CARLI website

Includes information on:

- You (& partners)
- Project (including abstract)
- Library Director signs

Detailed proposal outlining the proposed research project – includes:

- Description
- Methodology
- Scope
- Timetable
- Budget

Statement on how this project fits into the existing literature

Include a literature review or other relevant information about your project.

Projected outcomes

This section includes your evaluation methodology. What are your expected outcomes, how will those be measured and evaluated.

Statement outlining how this research will benefit the Illinois library community and the broader profession.

Plan for how the results of the research will be shared with the Illinois library community.

Multi-Year Projects

- Include in Section 1
- Detailed plan, year by year, with benchmark goals to be completed by which progress will be measured and reported at the end of the year.
- Detailed budget, year by year, and if applicable for each participating library.
- Annual progress reports, including progress on benchmark goals and budget reports for each participating institution, will be due to CARLI by July 31 of each year of the multi-year project.

Evaluation

- Each section equally important
- Thoroughness
- Impact on libraries and the library profession
- Potential to provide useful addition to existing literature

- before **February 22, 2015** – send draft to support@carli.illinois.edu to receive brief comments from CARLI staff
- **February 27, 2015** (Friday) – Proposals DUE – PDF to support@carli.illinois.edu with Cover Sheet
- **March 2015**
- **April 1, 2015** – Announcement of funded projects
- by **June 30, 2015** – Disbursement of funds
- **June 15, 2016** – Deadline to expend funds
- **October 15, 2016** – Final Reports Due (1 year projects)
