Naun ran a query in UIUdb identifying the ISBNs of everything in the database published in 2005 and sent this list to Blackwells to see what he would get if UIUC subscribed to this service. He has asked CARLI to do the same in the Universal Catalog and will check with Casey and Cathy on progress. More on this at a later meeting.

#### **OTHER:**

Joan asked if there would be any problems with Voyager's handling of 035s after installing OCLC's Connexion 1.7 upgrade. There shouldn't be any problems and Casey will update and re-distribute - the memo called 'Effect of OCLC Number Changes in the I-Share Environment' reminding I-Share cataloging staff how to configure their OCLC export options to properly address this problem.
