 - Voyager 7 offers many improvements for ACQ module; a spring forum to get ready for summer upgrade is possible.

- Approx. 22 libraries interested in VUFind, even though it is still in development; Paige is starting an FAQ page about VUFind. Preliminary tests from Eastern indicate students love it, but still in Beta stage.
- CARLI will offer training on Voyager clients this fall (cataloging, serials, acquisition, etc)
- CARLI Liaison Group is working on committee guidelines, including scheduling (example: forums)
