 - Was there something you did as a group but didn't have resources to do?
 - Not many drawbacks, have been able to do what we planned to do
 - Is there a way to do things (monthly meetings and forums) that are better?
 - Meeting in person with conference call option has worked well. Have used Google docs to share documents in meetings. May use WIMBA (or similar) for people on the conference call option when discussing a document; may be helpful for the monthly call-in.
 - Also discussed using WIMBA for supplemental training
 - Last year had 3 mini forums in different parts of the state was successful: less travel and more networking for people doing similar jobs in that area
 - What services would you like to provide to your patrons that the future ILS would be helpful?
 - Better interaction with accounting services at universities,
 - Provide email for faculty from acquisitions module (could be helpful for purchase on demand),
 - Search within Universal catalog could result in 'purchase on demand' button.
 - Go to circulation data from acquisitions module, ERMS integration with ILS, automated reports
 - Integrated new books list
 - Any questions for IUG?

 - Type of information that might be useful concentrated on the future of the ILS (what direction they are going to and what topics are covered)

- Was there something you did as a group but didn't have resources to do? Is there a way to do things (monthly meetings and forums) that are better? What mechanisms of communication from IUG do you need?
 - Helping libraries implement tools (example: STRAWN) that they don't have the staff or learning curve to implement, using trainers from experienced libraries. Would also help them adapt tool to their libraries. (travel and staff time were the big hold ups; also a lot of preparation work to be done)
 - Authority work more crucial and lack of authority is more apparent
- Is there a way to do things (monthly meetings and forums) that are better?
 - Really like the monthly meeting format and gives team a goal to meet deadlines. Most of work is done by conference call. Survey at the last forum regarding web format vs. in-person format; people like meeting in-person for the forum.

Team strongly feels that they have something to contribute to the selection of the next product
