#### **DECISIONS:**

- The committee reviewed and approved the edits the subcommittee (John, Elizabeth and Frances) made to the Book Digitization Initiative documentation and submission schedule.
- The committee viewed and approved the archive.org Camtasia tutorial Luann created. She will make minor edits next week.
- The committee discussed ideas for the Spring Forum, scheduled for March 5th at IIT. A subcommittee (Elizabeth, John, Heather & Mary) was formed to plan the event.
- The committee discussed ideas for a streaming media workshop. A subcommittee (Frances & Marlene) was formed to plan the event.
- The committee reviewed and edited the Collections Resources Clearinghouse topics.
- The committee edited the Collections Working Group Strategic Plan and updated the scope of work. The scope of work will need to be approved by the CARLI board.

#### **ANNOUNCEMENTS:**

- The last copy pilot project is continuing to receive donations. A home is needed for last copy LPs.
- CARLI is still subsidizing a two year membership (up to \$2,000) to the Center for Research Libraries (CRL).
- Digital Collections Users Group and Preservation Working Group have created a subgroup that will determine CARLI's involvement, if any, in digital preservation.
- The Electronic Resources Working Group is interested in joining with us to create a streaming media workshop.
- The Public Services Working Group is continuing to evaluate their open houses. In the Spring, a conference based on the anthropological study done on user behavior in Illinois is planned.
- The CARLI annual meeting is Oct. 30th at the I-Hotel in Champaign.

- Testing for the CARLI/UIUC pilot project of a purchase-on-demand program is underway with implementation expected by early Spring.
- Awards Program FY 2010 –All award checks have been sent out. List of funded projects are on the CARLI website.
- Awards Program FY 2009 All summations have been received and will be posted on the Wiki shortly.
- Awards Program FY 2008 All final reports have been received and are posted on the Wiki.
- Lynn announced the I-Share analysis will soon be sent to all I-Share directors and she would conduct several conference calls to field questions concerning the data.

- Elizabeth and John will conduct online webinars for the Book Digitization Initiative.
- Elizabeth will post the Book Digitization Initiative documentation on the CARLI newsletter, listserv, blog and make an announcement at the CARLI annual meeting.
- Lynn and Elizabeth will determine dates for Lynn's I-Share analysis conference calls
- The subcommittee of Elizabeth, John, Heather and Mary will meet to plan the events for the Spring Forum on March 5th.
- The subcommittee of Frances & Marlene will contact the Electronic Resources Working Group to plan the events for the streaming media workshop.
- All committee members should review and initial the new CWG strategic plan (which is posted on the Wiki) by our next meeting.
