CARLI Board Report and Office Report

- Membership voted to pass revised bylaws; bylaws and membership agreements will be sent out in mail soon, to be returned by March 31, 2010. There has been a change to a two tiered membership, governing and affiliate memberships. Affiliate memberships will not receive ILDS delivery. Governing members do not have to be I-Share libraries.
- Libraries will see new I-Share agreement; included in clearer language is the agreement that in the case of a patron defaulting on a payment, that bill cannot be transferred to the patron's home library. This will allow CARLI to work on consistent UB policies.
- The Board approved funding for the eXtensible Catalog project to keep it moving while they seek additional grant monies.
- U of I has mandated 4 furlough days for Academic Professional staff (that includes CARLI staff), to be spread across the next 4 months and CARLI does not expect the furloughs to impact meetings or work of CARLI.

- Discussion of VuFind record to clarify language and resemble brief record of Voyager 7
- Survey among usability testing group asking if they would like a webinar in Spring was positive and that is being planned.

- Specification for script that follows a best practice that automates removal of transactions of \$4.99 or less. IUG will read the specification and discuss next month
- Forum from Resource Sharing—trouble shooting circulation using quick and easy access reports, presented online

Discussion Items

- ILDS—Diane Day
 - Contract with ILDS expires June 30, 2011 and RFP will be written this fall. In a quick survey of delivery, most bags received within one to two days (as seen through label creation). No problems with supplies or libraries getting supplies.
- Liaisons Forum in June
 - Morning: Foundational refresher including how to navigate Web support. Small panel discussion of teams and their missions, content that they have dealt with over the past year. Team Liaisons or the Chair of the team can present.
 - Afternoon: Synthesize what people want for the future of ILS and present that and have small group discussions. Afterwards given 3 points from each functional area and have liaisons discuss these areas
 - Possible XC demo before afternoon breakouts
- Discussion about what we have learned from talking to our teams

- Decided to schedule another meeting with each team if they would like it, in addition to giving them an option to call in during the chairs meeting. The liaison will invite team to schedule meeting with IUG.
- Brainstorm ways to get more participants for presenting at forums
 - Emphasize the need for membership to 'give back' to CARLI
- Voyager upgrade update

- Discussion of possible updates:

 - CatER (discuss their report)-finalizing survey to send out
 - Usability Testing Volunteer Group—webinar planned for volunteers, questions have gone out from the OPAC team, no other updates
