# **Report from the Director/CARLI report**

CARLI is facing substantial cuts in budget, reorganization of reporting administration and strong financial challenges.

CARLI annual meeting will take place via webinar format this year.

Comfortable with move to VuFind interface for the universal catalog, especially the easy adaptability; the next 12-24 months will be active in terms of catalogs. Developer's time will be primarily focused on XC. Recent meeting about XC included some big universities worldwide. XC may be available to view in November with 2 million records.

Customizations & changes to VuFind will now be implemented after 5 pm to minimize impact on students' and instruction.

Senate Bill 51 impacts public universities purchasing and legal restrictions and may increase CARLI overhead by 100%.

Universal Borrowing standardized loan periods will be moving ahead.

Chairs and communication with IUG

• Teams will continue to meet monthly, or according to their specific needs. For now IUG will continue to send representation to each team and try to enhance communication.

VuFind issues:

- Time out for VuFind will be reset to 10 minutes in order to avoid account privacy issues (closing browsers does not end session; this is an issue on public workstations)
- Records unsuppressesed do not appear in VuFind until the following day
- A patron load will not change the barcode in VuFind.
- Error message on request failure cannot be more specific
- VuFind cannot limit to library location (as in 4<sup>th</sup> floor), nor search for prolific author; the loss of functionality is a trade off in terms of response time.
