- The Vision 2020 Taskforce has been charged with creating a vision for CARLI/I-Share in 2020. They would welcome input from the CWG.
- The recently published CLIR report #147 (<u>http://www.clir.org/pubs/reports/pub147/pub147.pdf</u>) contains information this group might find relevant as the report focuses on transforming research collections for 21st century scholarship.
