1. CARLI Office Report (Mel Farrell): Voyager 7.2.3 upgrade will be delayed. During testing some problems were discovered (slow response time), so the upgrade will take place at some time in the future. CARLI staff will be involved in Voyager 8.1 field testing this spring, so an upgrade could be to Version 8.
2. IUG report (Susie) Asked about UB reports and analyzing new standardization in the spring. Dallas inquired about who is reviewing standardization, Mel responded IUG will do the reviewing as well as individual sessions with CARLI staff. Li asked if it is possible to renew items upon arrival. They can, and individual matrices are set differently, in the CSU database, so different renewal results could be expected. There will be a re-evaluation of the new UB policies this spring.
3. In-person meeting this February: consensus is that most can make the originally planned date for the in-person meeting and/or the 'snow' date.
4. Some discussion regarding the maximum of \$4.99 to forgive UB patron fines, whether that amount was too low. A higher limit will be considered.
5. Mel's new tip & trick for sometime in January will be handling printed notices.
