CARLI Report: Lorna Engels

- Two changes have been made to VuFind:
 - There is now a mobile interface available to access the catalog.
 - Catalog users are now able to set a default location for where interlibrary loan (IL) materials should be delivered, and the cell phone number for the text me this call number feature. Once set, these preferences will auto-populate in the respective fields. The default can be set by accessing "Your account" and then clicking on the "Preferences" link.
- Voyager 8 will be in beta testing this spring. The general release will be available sometime this summer; however, if it is too late, the upgrade will not be implemented until the December 2011 academic break.
