- Cheryl appointed as minute-taker for April meeting

Old business

LC genre/form headings

Kristin reported that LC's latest press release stated that PSD would revise the LCCNs and MARC 21 coding of the genre/form authority records no later than March 1, 2011 and that all existing LCGFT authority records with an sh prefix in the LC Control Number (LCCN) would be cancelled and replacement records for them would be issued. Nothing has been done yet, so Kristin and Cheryl are postponing their report.

Spring Forum update

- Casey will give her presentation on Global Data Change as originally planned.

Discussions

- MarcEdit (Kristin, Mary). Andrea Imre has a conflict and won't be able to present with Kristin. Kristin has emailed one more person, but if they can't do it, it will be just her and Mary R. Mary R. plans a 15-20 minute presentation on clean-up of records and believes that having only two people presenting will be fine. Kristin asked if she could get MarcEdit live on a computer at UIS for her part of the session or if she should plan to bring her laptop. Based on past experience, Cathy thinks Kristin's laptop will be ok, but she will check with the people at UIS to see what they prefer.
- RDA (Mary, Susan, Emily). Will go with one title for all three sessions.
- Global Data Change (Casey). Casey has heard from Ex Libris that the new release of Voyager (v.8) has been pushed back to mid-July. Since CARLI upgrades I-Share only during semester breaks (i.e. summer and winter), this means that the summer upgrade will probably be to version 7.23. The earliest that the upgrade to version 8 would take place would be winter of 2012, but it may not happen until summer of 2012. Given this delay, Casey asked the committee if we still wanted her to give her presentation on the introduction to version 8. There was a brief discussion of a session where we broke into small groups, but we did not have an idea for a topic. The committee decided that since time was so short, we would keep the forum's schedule as it is, with Casey presenting as originally planned.
