Decisions:

- Minutes of the March 18, 2011 meeting were approved prior to the meeting.
- The Board elected David Carlson as the 2011-2012 Vice-chair/Chair-elect.
- The Board accepted the recommendations of the Collections Working Group for maintenance of the Scholarly Communications web page.
- The Board reviewed the Collections Working Group document 'Number of Copies Recommendation for I-Share.' The Board referred the recommendations to the Executive Committee for revisions in preparation for a final vote later this summer. The Board thanked the Collections Working Group for their work.
- The Board accepted the annual reports from the Collections Working Group, Digital Collections Users' Group, E-resources Working Group, I-Share Users' Group, Preservation Working Group, and the Public Services Working Group. The groups were thanked for their work.
- The meeting was adjourned at 2:15 p.m.

Announcements:

• Results of the 2011 Board election were announced. The newly elected members, who will serve three-year terms (July 1, 2011–June 30, 2014) are: Paula Kaufman, University of Illinois at Urbana-Champaign, representing public universities, and Christine Frank, Rush University, representing private colleges and universities. Current Board member Connie Bakker, College of Lake County, was re-elected to represent community colleges. Allen Lanham, Eastern Illinois University was appointed to serve a 1-year term representing public universities, and J. Richard Sayre, Monmouth College was reappointed to a 1-year

- term representing private colleges and universities.
- The Board thanked outgoing board members Brad Baker (Northeastern Illinois University), and Jan Chindlund (Columbia College) for their service.
- The Board meeting dates for 2011-2012 will be September 9, December 2, March 9, and June 15.
- CARLI staff is working on the implementation plan for the FY2012 Patron Driven Acquisition program for print materials.
- CARLI is planning for a Request for Proposal for e-book purchasing later this year.
- CARLI has finalized the process for requesting materials from the Five College Library Depository through our affiliate membership agreement.
- CARLI will roll out a new VuFind enhancement later this month that will provide a library location facet for local catalogs.
- CARLI is working with XC to develop the OAI and NCIP toolkits that are compatible with our consortial Voyager application.
- CARLI has created a demonstration server running all of the XC modules in order to begin testing system
 performance.
- CARLI will upgrade to Voyager version 7.2.5 beginning at 5pm on Friday, July 8.
- CARLI will discontinue availability and support of TomCat WebVoyage for I-Share libraries beginning
 June 30, 2011. Any remaining TomCat users will be automatically redirected to WebVoyage Classic after
 that date.
- CARLI will begin the Voyager license renewal process this fall. The current contract expires on June 30, 2012.
- Recordings of the e-resource licensing webinars held this spring are available on the CARLI web site.
- CARLI will hold a Burn Simulation and Recovery Workshop at the Illinois Fire Service Institute on June 30.
- CARLI is planning to hold in-person meetings with the Governing directors in the fall. Dates and locations have not been set.
- The 2011 CARLI Annual Meeting will be held as a webinar. The date and the meeting topic have not been set.
- CARLI has completed the product and hardware upgrades for SFX and CONTENTdm resulting in significant performance improvements.
- OCLC, Inc. has been awarded the contract for Resource Discovery and Sharing for Illinois Libraries (i.e., discovery, cataloging and interlibrary loan services) as a result of a formal Request for Proposal process conducted by the Office of the Secretary of State. The State Library is distributing pricing information for ILLINET/OCLC Services for FY12 (July 1, 2011-June 30, 2012) and FY13 (July 1, 2012-June 30, 2013) to all Illinois OCLC member libraries. Pricing for FY13 will remain the same as FY12.
- CARLI is developing a new copyright information page for the web site. A draft will be available for review at the September Board meeting.
- CARLI will initiate a web site redesign in FY 2012.
- No final information is available about the state budget at this time.

Tasks assigned:

 The Board directed CARLI to develop instructions for members about how to use the Five Colleges Depository.

- The Board directed CARLI to begin planning for informational webinars regarding the number of copies recommendation for I-Share.
- The Board directed CARLI to prepare a letter to Lt. Governor Sheila Simon expressing preliminary support for a state version of the Federal Research Public Access Act.
