Activities

IUG met 6 times over the course of the year 3 times by phone. Business items included the election of Ted Schwitzner as chair for the 2012-2013 term. New liaisons were assigned for the Acq/Ser, Cataloging and Instruction teams.

Key areas of IUG involvement this year, in either a direct or advisory role, were; E-books, Patron Driven Acquisitions, Voyager upgrade timing, Discovery tools *(including the March 15th Discovery tool forum)*, increased media lending, and with the Resource Sharing team UB Blocks.

Major accomplishments this year included the organization of a joint meeting with the CARLI collections working group on issues concerning E-Books, specifically issues about sharing these resources. Can E-Books be loaned? Can a consortial purchasing arrangement solve some of the problems concerning E-Book sharing? Following our discussions CARLI began investigating possible consortial purchasing of E-Books.

IUG held an informational webinar Friday April 13th, attended by 97 registrants. Topics included an introduction to IUG and its work, a tour of the CARLI and ExLibris websites, voyager development, the future of the ILS, and XC news.

IUG drafted a survey for membership concerning the timing of upgrades; the survey can be administered as needed.

Media lending issues were addressed. This is an action item next year, but investigation has begun into issues concerning why institutions are hesitant to loan media. Cathy Salika was able to come up with some very interesting data on media lending, calling into question many of the issues people cite when refusing to lend media. This data has been disseminated to IUG and at a Resource sharing forum among other places.

Three IUG members presented at the ELUNA conference in Salt Lake City. The presentation was entitled *Consortium as a Cloud* and drew parallels between the I-Share environment and cloud based or hosted systems.

IUG wishes to thank outgoing IUG members Carlos Melian, Nancy Laverdiere, Belinda Cheek, and Board Liaison, Mary Case for all of the hard work on behalf of IUG

Accomplishments:

Webinars/Forums: Conducted three Fall Forum webinars, Nov. 14-16 on the following topics:

- An overview of best cataloging practices for the I-Share environment
- An overview of database maintenance tools available to I-Share libraries and the types of problems they can help address

- A step-by-step description of cataloging e-journals following the CatER recommendations
- With IACQ co-hosted E-books forum (see above).

Documentation & best practices:

- Updated the ICAT Interim Recommendations for Managing RDA in I-Share
- Completed discussion of the Cataloging of Electronic Resources Task Force (CatER)
- Developed a document to provide guidance on the use of Library of Congress genre/form headings
- Reviewed and approved various additions prepared by CARLI staff to the "Suggested Priorities for Bibliographic, Holding, and Item Record Maintenance" document.
- Developed recommendations and guidance for member libraries using the WorldCat Digital Collection Gateway to transform CONTENTdm records into MARC records
- Tested new additions to the consortial tag tables for use with MARC validation functions in the Voyager cataloging client

• Established a relationship with the Dominican University GSLIS internship coordinator, to encourage I-Share libraries in the Chicago area to consider providing cataloging-focused practicums or internships for Dominican students

- The Instruction Team's first Unconference took place at Illinois Wesleyan University on January 10th, 2012. The event was entitled: "CARLI Instruction Team's Library Instruction Unconference: Your Voice Needed!" The idea behind the Unconference was to have participants, drawing on their own ideas, expertise, and interests, generate the Unconference topics and then self-select into groups for discussion.
- "Library Instruction for a Diverse Student Population." June 8th at Chicago Theological Union. Topics for the forum include;
 - Make a Connection: Library Services for International Students
 - Intellectual Property and Attribution in a Cross-Cultural Context: Understanding International Students' Attitudes Towards Citation and Plagiarism.
 - Welcome to my classroom; did you learn anything today? The international student in the library instruction classroom.
 - Stereotype Threat: Effects on Achievement and University Success

Social Media

- Social Media Initiatives included Twitter hashtag for communication at IBI events and expanded use of CARLI Blog.
- The Instruction was wiki was renamed to better reflect the content on the page. The wiki was reorganized with dated material removed.

Charge

In November a team member noted that the charge given to us by CARLI no longer accurately reflects the work the team has been doing for the past several years. In early 2012 the team agreed to request that IUG and CARLI review our charge and consider updating it.

Future Objectives

- Expanded use of Instruction Materials portion of the CARLI wiki as a place for I-Share member libraries to collaborate on instruction initiatives
- Work toward more beyond I-Share involvement in events as the charge is expanded
