

I-SHARE FY2022: BY THE NUMBERS

- CARLI staff resolved 2,058 support inquiries from our I-Share libraries about Alma and Primo VE between July 1, 2021-June 30, 2022.
- CARLI staff opened over 100 Cases with Ex Libris to address Alma and Primo VE related issues for I-Share member libraries.
- CARLI staff presented nearly 50 topical webinars between July 1, 2021-June 20, 2022, on Alma and Primo VE including:
 - Open Office Hours
 - Tech Services Q&A
 - Let's Talk about Fulfillment (LTAF)
- CARLI provided 400 paid registrations to ELUNA Learns 2022 sessions for members.



I-SHARE 2022: CONTINUING TITLE CLEAN-UP

Early 2021: Ex Libris identified CARLI had exceeded the bibliographic title count metric for our license for I-Share libraries.

CARLI Response: Title Reduction Project

- Addressed duplicate electronic resource collections and set up central management of e-resources in Network
- With \$165,000 from UI System Office, CARLI hired CMC staff at IHLS to help with duplication and other identified issues in Network Zone.
- After continued conversations with Ex Libris, reached new agreement about how to count bibliographic titles

Results: Current bib count is 21.2 million records

- CMC staff continue their work to clean up the Network Zone and improve bibliographic record quality through State Funded grant funds awarded to IHLS.
- I-Share libraries should link your IZ records to the NZ when appropriate; this is key to maintaining a healthy consortial count


