Why would I export records?

- OCLC holdings reclamation, or streamlined holdings update
- Sharing records to another system
 - Rapid ILL, Find More Illinois
- Sharing records to a vendor
 - OCLC GreenGlass; BackStage Library Works; EDS
- Working on records outside Alma
 - MarcEdit clean-up
 - Data analysis

What's the difference between export and publishing?

- Scheduling
 - Publishing may be scheduled to run regularly
 - Exports are on demand jobs
- Content modification
 - Pub: Includes options to enrich bibs with other various other data
 - E.g., item data, linked data, management tags
 - May apply normalization rules.
 - Export: Includes option to enrich bibs with holdings data
 - Other data types (items, portfolios) have unique export jobs
- Output Options
 - Pub: May send to FTP, OAI, Z39.50
 - Export: May send to FTP

- Is anyone using EDS?
- Would this be a way to get holdings into OCLC? (LHRs)
 - LHRs are a separate process in Alma
 - LHRs use publishing profiles, so the work is similar
 - Watch this space! We'll be in touch soon on getting the process right.
- What are benefits of setting LHRs?
 - Ability to support your library's ILL staff
- If LHRs need updating, should we wait to do that or work on fixing them?
 - If you have them in OCLC, you/we can request the data from OCLC.
 - If your Alma data are more up-to-date, then start clean-up now.
 - Primo VE prefers to show 866 data (out of the box)

Q&A on Exports

- Does Alma automatically send data to OCLC for new items?
 - Yes, using the Data Sync publishing profile
 - Data sent daily at 5:00 a.m. for new items and deletions
 - Changing export to OCLC to "Don't publish" deletes, as does record deletion.
- What about Google Scholar publishing?
 - See CARLI website
 - Publish Primo VE to Google—needs research
- Collection Manager is just better for managing WorldCat holdings for e-resources.
 - Can do more with publishing as well

Looking around at other consortia and evaluating what works and doesn't for us, we may want to make some changes:

- Disabling matching to CZ bib records
 - Fine tunes matching only to records in IZ and NZ
 - Ignores any OCLC numbers in CZ bibs that might match
- Disabling Cataloging Levels
 - Not well understood, not consistently applied
 - Hinders some processes, irrelevant to other related processes
- Item Description Patterns
 - Sharing patterns could make item descriptions more uniform
 - More uniform descriptions make AFN requests for multi-part resources work

- Cleaning up item descriptions
 - Common description patterns
 - Cleanup of enumeration and chronology fields
 - Alma expects Enumeration should be a number (or letter), no caption
 - Similarly, Chronology should be a year, or month, or day
- P2E Cleanup and Bib-Inventory Format Matching
 - Identify and set item material types
 - Identify and set portfolio material types
 - Separate e-inventory from bibs used for physical inventory
- Linking Records to NZ / Resolving Duplicate Bibs
 - IHLS CMC team continuing to help through June
 - CARLI staff working on better reports for finding and evaluating duplicate bibs More soon
 - Finding and cleaning up bibs with multiple OCLC 035\$a

- Alma Metadata Editor
 - No news on when the old MDE goes away for good.
 - New template functionality in <u>April</u>.
- DEI work
 - CARLI staff and Technical Services Committee
 - Evaluating and refining DEI processes from SUNY, CSU
 - Testing in sandboxes, proposals to CARLI Board
