## Migration Forms:

- Used by the extract program and Ex Libris to migrate your data from Voyager to Alma.
- Created by CARLI based on information your institution submitted on:
  - I-Share Alma Migration/Implementation Form
  - Location\_List\_XXX.xlsx
  - Alma\_libraries\_xxx.xlsx
- Shared via Box in October to help you evaluate your test migration results.
- Migration Forms are **different** than Configuration Forms.





CARLI Staff have again created an online survey to gather information, this time to <u>update</u> your migration form.

- Some institutions may have *no updates*. This is completely fine. Submit the online survey even if you have no changes.
- Some institutions may have already discussed changes with CARLI staff, or edited your existing Alma Test Migration Form XXX\_Final.xlsm: submit this online survey with your changes.
- CARLI Staff will take responses to the online survey input by your Alma-Primo VE contact and use them for your production Migration Form.

## MIGRATION FORM UPDATE DETAILS

- All questions but one, Question 17, have default answers, usually "No Change".
- No Change means "No change to the answer as found on the Test Migration Form".
- Details for each answer option are provided.
- By design not all questions on the Migration Form have a question on the online survey.
- Where applicable, CARLI recommendations are provided.
- Leaving as "No change" is ok and expected in most cases, except...



## LOCATIONS, LIBRARIES, AND VENDORS

Changes that must be reported on this online survey:

- Locations that contain electronic resources for P2E
- New Location(s) and/or changes to location mappings
- New Alma Libraries
- New Vendors



Two optional questions:

- Retain Course Reserves containers?
- Retain Acquisitions fund structure?
- CARLI expects that most libraries will NOT choose to retain these data. This is the default.
