Update on OCLC Data Sync

- CARLI is changing your OCLC Data Sync publishing ftp connections to point at OCLC's new file exchange server by September 30.
 - Processing and matching should work the same as what we are currently seeing.
- What is coming in early 2021:
 - More detailed reports
 - Reports generated sooner
- CARLI is adding a secondary fix for LDR 00-04 containing hyphens.

Due Date Extensions 2/1/2021

CARLI Board of Directors voted to extend I-Share resource sharing due dates, and optionally local circ, to 2/1/2021

- Proposal came from many of the participants at an open discussion session for CARLI library directors held on 9/3/2020.
- The proposal that went to the Board was drafted by CARLI Office staff.
- Details were emailed to I-Share Directors, I-Share Liaisons, and Alma Primo Contacts on 9/16/2020.

Due Date Extensions 2/1/2021, upcoming work

CARLI staff:

- Will change the due date of everything* that is currently checked out in Alma and due before 2/1/2021, to be due 2/1/2021.
- Will adjust Alma Configuration to set a fixed due date of 2/1/2021 for all I-Share and local* loans for materials that are checked out in Alma.
- Will NOT enable the Alma fulfillment jobs, rules, and settings that cause either local or I-Share patrons to be further fined, billed, or blocked.
- WILL enable the jobs, rules, and settings that create overdue notices on the schedules set by the libraries.

*To opt out of the bulk due date extension for local circulation, send email CARLI support.

- This exemption can include:
 - Opting out of the one-time bulk due date extension for your patrons' loans of your items.
 - This can be for all local patrons/materials, or for a subset of local patrons/materials.
 - Opting out of the term loan due date of 2/1/2021 for ongoing loans of your materials to your patrons.
 - This can also be for all local patrons/materials, or for a subset of local patrons/materials.

Ending Overdue Fines and Processing Fees

CARLI Board of Directors approved two proposals that will end the practice of I-Share libraries charging overdue fines for their main circulating collections and "processing fees" for any lost materials.

- This covers both I-Share resource sharing transactions (already overdue fine exempt) and also "local" circulation to patrons affiliated with the institution.
- At the discretion of the institution, overdue fines may still be assessed to local patrons late in returning limited access collections such as reserves, equipment, and other special materials.
- Libraries may still bill any patron for the replacement of lost materials, but may not charge an additional processing fee.

Ending Overdue Fines and Processing Fees

These proposals were discussed by the Board at their June 2020 meeting and subsequently put out for public comment.

- The comments received were overwhelmingly in support of suspending both overdue fines and processing fees.
- The comment period is now closed but those received are available for review along with background material about this policy change: <u>https://www.carli.illinois.edu/call-public-comment-i-</u> <u>share-fines-and-fees</u>.

Ending Overdue Fines and Processing Fees

- These policy changes are mandatory for I-Share libraries, but all CARLI Governing Member institutions (i.e., non-I-Share) are encouraged to adopt them.
- I-Share libraries may implement these changes on their own or ask CARLI to make these policy configuration changes on their behalf.
 - This work may be done at any time and must be completed by January 1, 2021.
 - Each I-Share library should complete this form (<u>https://go.uillinois.edu/ishare_fines_fees_end</u>) by November 10, 2020

Ending Overdue Fines and Processing Fees Upcoming work

- Workflow to implement changes
 - Alma Configuration at the Institutional Level > Fulfillment > Terms of Use (TOU) > Loan TOU
 - Lost Item Fine (aka processing fee)
 - Maximum Fine
 - Overdue Fine
 - Recalled Overdue Fine
 - Grace Period
- Live Demonstration of Configuration

- The Ex Libris Idea Exchange allows library staff at institutions using Ex Libris products to:
 - Share ideas for enhancement/development.

Alma Fulfillment- Known Issues Demonstration of Workflows/Workarounds

- Alma using incorrect "On Hold" letter for incoming AFN items.
- Staff receive an error message after checking out AFN materials to a patron and clicking "Done."
- Alma does not display institutional affiliation or contact information for another I-Share library's patron with material on the hold shelf.
- Requests placed by patrons in Primo VE are canceled, even though copies should be requestable.
- Local requests converted to Resource Sharing requests stuck in "waiting to be sent" status.

- The CARLI Office currently has an open position for a Library Services Coordinator
- Required: M.S. in LS/IS and at least 1 year one year of experience working in a position with responsibilities that include using and/or supporting online library systems and services
